

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.executivecardetail.com and Executive Car Detail Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Executive Car Detail Inc. include www.executivecardetail.com and ECD. The ECD website is a information, booking or scheduling, bill pay, and customer service site. By using the ECD website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, ECD may collect personally identifiable information, such as your:

- First and Last Name

- Mailing Address

- E-mail Address

- Phone Number

- Employer

- Job Title

If you purchase ECD's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

ECD may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

- Gender
- Race
- Religion
- Political Affiliation
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

ECD collects and uses your personal information to operate its website(s) and deliver the services you have requested.

ECD may also use your personally identifiable information to inform you of other products or services available from ECD and its affiliates.

Sharing Information with Third Parties

ECD does not sell, rent or lease its customer lists to third parties.

ECD may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. ECD may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ECD, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

We use Google Webmaster Tools and Google Analytics Tools to track customer engagement with information and conversions to determine the clearest method of communicating authentically with online or in-person visitors and clients.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by ECD. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the ECD website.

Use of Cookies

The ECD website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
